## Nomination Form

### Award Criteria:

The nominee's work must meet at least two of the following criteria: (a) provide services to victims, perpetrators or child witnesses of domestic violence in order to break the cycle of domestic violence, (b) protect the community through the provision of services including advocacy, information and treatment services which promote victim safety and facilitate their active engagement in the criminal justice system, (c) demonstrate collaborative work to ensure seamless, effective service delivery to those affected by domestic violence, (d) demonstrate an outstanding contribution to victims or perpetrators of domestic violence and abuse through diligent and sustained effort that supports the goal of breaking the cycles of domestic and sexual violence.

### Selection:

Nominations will be screened to determine eligibility. A selection committee, independent of HomeFront, will review all eligible nominations and will select one award winner from each nominating category.

### Awards:

Nominees and their nominators will be notified if they have been selected as an award recipient. The award winners will be honoured at the HomeFront Selinger Awards Celebration on November 25, 2010.
